Martin Bujard

is research director of the Family and Fertility Division at the Federal Institute for Population Research

Martin Bujard studied political science, law, economics and psychology at the University of Heidelberg (M.A.) and received his doctorate in 2010. In 2019, he attained his postdoctoral qualification in sociology at the University of Mainz. After working as a managing director, research associate in the German Bundestag and coordinator of the academy group "The future with children", he has been working at the Federal Institute for Population Research since 2011, and as deputy director since 2020. He has held a professorship at the University of Heidelberg since 2022.

Eva Rehfuess has been teaching as a professor of public health and health services research at Ludwig Maximilian University (LMU) in Munich at the Institute for Medical Information Processing, Biometry and Epidemiology and at the Pettenkofer School of Public Health since 2018. Since 2015, she has also been an adjunct professor at the Gillings School of Global Public Health at the University of North Carolina at Chapel Hill. She completed her postdoctorate qualification in epidemiology and public health in 2014 at the Faculty of Medicine at LMU Munich. She began her academic training with a degree in biology at the University of Oxford, followed by a PhD in epidemiology and public health at Imperial College London.

Johanna Sell

heads the Health Care and Hospitals Subdivision at the Federal Ministry of Health, Berlin

Johanna Sell is a fully qualified lawyer and has been head of the Health Care and Hospitals Subdivision at the Federal Ministry of Health since 2019. In this position, she is currently playing a key role in implementing the recommendations of the government commission for a fundamental reform of both hospital remuneration and emergency care. Previously, she was deputy managing director of the Medical Review Board of the Statutory Health Insurance Funds (MDK) Bayern, where she was responsible for managing the nursing care division.

Barbara Steffens

heads the North Rhine-Westphalia regional office of TK (health insurance fund)

As head of the North Rhine-Westphalia regional office of TK (Techniker Krankenkasse), Barbara Steffens has been responsible for health policy work and contractual relationships with statutory health insurance physicians' and dentists' associations, hospitals, nursing services and hospices since 2018. She also oversees state-wide media relations. From 2010 to 2017, she served as minister of health, emancipation, care and the elderly for the state of North Rhine-Westphalia, and prior to that, she spent ten years as health policy spokesperson for the Green Party in the state parliament. She is also involved in the North Rhine-Westphalia health care system, including as a board member of "MedEcon Ruhr e. V" (health economics network).

Boris Velter

is the former head of the management team at the Federal Ministry of Health

Since 1997, Boris Velter has held various positions in the political arena, including from 2006 to 2009 as head of the coordination unit "Liaison between the federal government, states and the associations" in the management department of the Federal Ministry of Health under minister Ulla Schmidt. In 2013 he was state secretary in the Berlin Senate Department for Labour, Integration and Women's Issues and held the same position in the Senate Department for Health, Care and Equality from December 2016 to December 2018. In 2019, he became special representative for medicine and research to the governing mayor of Berlin. Under federal minister Karl Lauterbach, Boris Velter was head of the management team at the Federal Ministry of Health from 2021 to 2025.

Maike Voss

heads the communications and consulting agency Neues Handeln

From October 2022 to June 2024, Maike Voss was the managing director of the Centre for Planetary Health Policy (CPHP), a thinktank founded by the German Alliance on Climate Change and Health. She played a key role in the formation of the CPHP and quickly established the young thinktank as a relevant research and consulting institution. Previously, Maike Voss headed the global health governance research group at the German Institute for International and Security Affairs in Berlin. Her research focuses on the governance of health within planetary boundaries, in particular the social, economic and political drivers and barriers to health promotion and prevention, as well as the interactions between health, climate change and security.
